DUTIES: We would stress the self-help nature of this club. There are no paid staff, all duties are carried out by the club's members; it is important that members carry out three half day duties or two full days per year.

DECLARATION So far as it also applies to members of the family I declare that:

- Each craft used by me or my family and parked, used or sailed at the Club's premises or events has a valid certificate of insurance which provides adequate cover against third party liability.
- I will comply with the Club's Articles of Association and current Byelaws including any lawful changes made from time to time and in particular I have noted those Byelaws limiting the Club's liability in respect of member's safety.
- I understand that the Club is only able to provide safety facilities during the hours of a Club event. Outside these hours no cover is provided and members sailing alone are advised to have at least a shore based observer. In particular parents and guardians have sole responsibility for the supervision and control of their children and wards. Even during Club events the Club cannot be expected to exercise supervision or control for children or any other person.
- I will indemnify the Club for each child under 18, named within the Family Membership, against all liabilities, actions, loss, damage or injury howsoever caused by or to that child.
- I have noted the requirement that the sticker issued for each boat is displayed and, in the case of boats kept in the dinghy park, visible below the cover.
- I will perform the number of duties required of each member every year.**
